PART A - INTRODUCTION

1. Information on how to enter and Prize details form part of these terms and conditions.
2. By participating in the Competition, entrants accept and agree to be bound by these terms and conditions. For the avoidance of doubt, the terms and conditions include the Schedule above.
3. Entries must comply with these terms and conditions to be valid.

PART B - PRIVACY

4. The Promoter will collect and use each entrant's personal information for the purposes of:
 - i. conducting the Competition (which may include disclosure to third parties for the purpose of processing and conducting the Competition) and for promotional purposes, public statements and advertisements in relation to the Competition;
 - ii. providing information about the products and services offered by the Promoter and its related companies and its affiliated retailers; and
 - iii. research to improve its products and services.
